#### **Executive Director's Message**

State Fiscal Year (SFY) 2020 was about building foundations, including:

- ADAMH constructed a new way for choosing July 1, 2021, services. The model ensures the most important and helpful programs at the best cost are purchased for the community.
- When COVID-19 appeared, ADAMH quickly changed how it worked to support clients, agencies, and the ADAMH Board. Agencies rapidly began or expanded telehealth services to ensure client care was available even with the challenges and trauma of COVID-19!
- The ADAMH Board sought and received a variety of optional grants. For example, one grant added a fulltime substance use counselor to the jail. Another grant provided a telephone line for persons suffering from COVID-19-related distresses.
- Two deputy director positions were planned to fill gaps in Board staff administrative capacity. The process began early in the year with the model refined over time. An Ad Hoc Search Committee interviewed many candidates; an offer was extended in June and an associate director started mid-August.
- Documents for ADAMH Board and committee meetings grew from simple motions to formal resolutions. These changes increased written information for Board member decision-making and transparency.
- Technology to support the ADAMH Board and committee meeting preparations and organization of contracts and other documents led the Board to approve in June 2020 ARC (ADAMH Resolution and Contract Management) System, an adaptation of the Fairfield County Commission Resolution Management System.

We look forward to SFY 2021!


SFY 2020 Revenues

#### **All-star Celebration Annual Dinner**

On March 19, 2020, the Fairfield County ADAMH Board planned to hold its All-star Celebration Annual Dinner at the Pickerington Senior Center, but unfortunately, COVID-19 cancelled the event. However, Chairperson Joe Sidon still honored Cathy Ely, Ph.D., and Marie Ward, Ph.D., with Friend of ADAMH Awards. Sheriff David Phalen received the ADAMH Lifetime Achievement Award, and Officer Eric Wagner received the first C.I.T. Officer of the Year Award.



Pickerington Local School District's (PLSD's) Prevention Coordinator Cathy Ely, Ph.D., leads the district's team of school counselors and social work interns to provide social emotional learning support to the district's students. Dr. Ely created and facilitates an extremely successful social work intern program in partnership with The Ohio State University and Ohio University. Dr. Ely collaborates with community agencies to initiate school-based services at PLSD that include grief counseling by FAIRHOPE Hospice, mental health counseling and The Incredible Years prevention program by Ohio Guidestone, and substance use prevention services and counseling by The Recovery Center.

She has also worked to expand the school-based mental health services provided by New Horizons Mental Health Systems.

Superintendent Marie Ward, Ph.D., of the Fairfield County Education Service Center was instrumental in implementing the PAX Good Behavior Game (GBG), an evidence-based universal program, into Fairfield County classrooms. Dr. Ward submitted a proposal to the Fairfield County ADAMH Board to fund five PAX trainings for teachers and other staff in Berne Union, Liberty Union, Walnut Township, Fairfield Union, Amanda Clearcreek, and Bloom Carroll schools. By the end of State Fiscal Year 2021, a total of 200 school staff will be trained in PAX GBG.





With integrity, commitment to excellence, and community involvement, Fairfield County Sheriff David Phalen provided high-quality leadership to the Sheriff's Office during his 17 years in office. Due to his many partnerships with ADAMH and its Network of Care Agencies, he initiated the carrying of Narcan in Fairfield County Sheriff cruisers, co-founded the Fairfield County Opiate Task Force, and collaborated in the Harold Rogers Grant implementation. During his tenure, partnerships were created to provide a crisis clinician in the jail, teach Mental Health First Aid to deputies in the jail setting, and place a substance use disorder counselor and two peer supporters in the jail.

Pickerington Police Officer Eric Wagner (pictured on the left with Project F.O.R.T.'s Scott Duff) supported a client identified by Project F.O.R.T. When the client decided to enter rehab for several months, Officer Wagner arranged a foster family for the client's dog. After the client completed treatment, Officer Wagner arranged the reunion between the client and his dog. Officer Wagner, a trained C.I.T officer, displays a tremendous amount of compassion toward the citizens of Pickerington who suffer from mental health and substance use disorders. The community of Pickerington is lucky to have Officer Wagner.
