# SFY 2021 ANNUAL REPORT

#### **"BEHIND THE MASK"** JULY 1, 2020 - JUNE 30, 2021



#### **Executive Director's Message**

State Fiscal Year (SFY) 2021 was another challenging year in Fairfield County. As we look behind the masks, we see the COVID pandemic changed our local behavioral healthcare system needs and approaches in 2020. SFY 2021 continued to throw obstacles and challenges in our way, yet our providers, Board members, and staff persevered.

Our providers all adapted and pivoted their service delivery to continue to serve people in the midst of the pandemic and we are proud of their flexibility and commitment to serving the residents of Fairfield County. From masks to telehealth and social distancing, our agencies did what they needed to keep serving people. However, as we look behind the masks, some populations and services just didn't adapt well to telehealth and social distancing. Our providers also struggled to recruit and hire clinical staff. While this was already difficult, the pandemic ramped it up to another level. The ongoing stress of COVID has escalated mental health and substance use needs that we continue to look for ways to address in our community through new funding and approaches. Our Board members also had to adapt to virtual meetings and barriers to the "normal ways" of doing business but were successful at completing their work.



On the bright side, there have been opportunities for new funding and resources to address and mitigate these issues. The ADAMH Board was able to secure grants from the Ohio Department of Mental Health and Addiction Services to fund new programs. These include:

- urgent support and wellness services for healthcare workers during this time of crisis,
- an innovative approach to the opioid epidemic in our community to break the cycle of addiction when persons are incarcerated,
- reaching out to break down stigma and provide services to persons in rural communities in the county, and
- addressing addiction issues in pregnant moms.

Additionally, we were able to access funding from the state to escalate distribution of naloxone (a.k.a. Narcan) to address and mitigate rising overdose deaths. We continued our activity on our Crisis Stabilization Unit for the county as we prepared to break ground and start the construction on the site in SFY 2022.

In the ADAMH office in SFY 2021, we experienced notable staff changes as our longtime executive director and program coordinator retired and new persons learned these positions. Our new executive assistant also started, and we hired our new full-time finance and operations director to start work early in SFY 2022. The new staff members bring energy and unique skills to the office, which created a nice balance to the experience and wisdom of existing staff. We used SFY 2021 to invest in increasing our organization and efficiency. I am proud of our ADAMH staff and Board members for the way we have embraced new practices and tools to bring our team to the next level in organization to enable the work of our office to be effective and meaningful for Fairfield County.

Stay well — hopefully looking forward to when we will be able to emerge from behind the masks in SFY 2022!





ADAMH Fiscal Year 2021 Revenue by Funding Source




ADAMH Fiscal Year 2021 Provider Agency Services by Type




#### **ADAMH Fiscal Year 2021**

#### **ADAMH Impacting the Community**



Volunteers at First Be a Smart Cookie Drive-through Narcan Giveaway and Training

Despite the extreme heat and humidity on July 9, 2020, the Fairfield County Alcohol, Drug Addiction and Mental Health (ADAMH) Board in partnership with Project F.O.R.T. (Fairfield County Overdose Response Team), Kroger, and the Fairfield County Opiate Task Force distributed lifesaving Narcan kits to approximately 70 community members during the first-ever free Be a Smart Cookie Drive-through Narcan Giveaway and Training event in Kroger's parking on North Memorial Drive in Lancaster. Staff members representing the Fairfield Department of Health, Lancaster Fire Department, Lancaster Public Transit, Lancaster Recovery Services, Lutheran Social Services, New Horizons, OhioGuidestone and The Recovery Center provided participants with a Narcan/naloxone kit, training, drug disposal (Deterra) bag, community resourc-

es, and a cookie, because July 9 happened to also be National Sugar Cookie Day. Counselors were also onsite for any needed assistance.

The event was free thanks to Grant No. GA1RH33529 from the Health Resources and Services Administration (HRSA), an operating division of the U.S. Department of Health and Human Services. No registration was required. Participants just had to drive or walk up to the event booth to receive their goodie bags and brief one-on-one Narcan/naloxone training. Because of COVID-19, event volunteers wore masks, social distanced as much as possible, and encouraged the use of sanitizer onsite.

At the Amanda Community Watch Event for the Opiate Task Force on September 5, 2020, ADAMH and Project F.O.R.T. shared a booth that 20 people visited to obtain information.

On September 29, 2021, the Fairfield County ADAMH Board virtually offered the free one-day Advanced Crisis Intervention Team (C.I.T.) Training for Law Enforcement to 12 police officers in Fairfield County who previously completed the 40-hour C.I.T. Training. Advanced C.I.T. included educational

sessions on the Pink Slip Process (which agency clinicians were also invited to attend), Critical Incident Stress Management, and a Community Resources Update.

During October and November, ADAMH participated in virtual and in-person events and trainings as follows:


- Matrix training 10/1/20 ADAMH reached 25 people.
- Eye Movement Desensitization and Reprocessing (EMDR) training 10/1/20 – ADAMH reached eight people representing four agencies.
- Glow Walk 10/3/20 ADAMH reached 100 people.
- Ethics for Social Workers and Counselors training 11/12/20 ADAMH reached 30 people.
- Strategies for Effective Supervision training 11/12/20 ADAMH reached 20 people.

David Suman coordinated not one but two free online Ohio Department of Mental Health and Addiction Services Peer Recovery Supporter trainings in SFY 2021. The first was held March 15–19 and 22–26. The second virtual training took place June 14–18 and 21–25. Individuals in recovery from a mental health or substance use disorder who want to help their peers may become certified peer recovery supporters after completing a two-week course in addition to some pre-work.

Thwarted for a second year in a row due to the negative impacts of COVID-19, the Fairfield County ADAMH Board All-star Celebration Annual Dinner became the All-star Celebration Video, which was



shared on ADAMH's YouTube channel on May 21, 2021. Chairperson Jonathan McCombs, Ph.D., honored New Horizon Mental Health Services' Megan Golden, LISW, CDCA, and Fairfield Medical Center's Angeline Stergiou, M.D., with Friend of ADAMH Awards

On June 9, 2021, Latina Duffy and David Suman worked the ADAMH booth at the new Pickerington Community Resources Expo held at the Pickerington Main Library.
