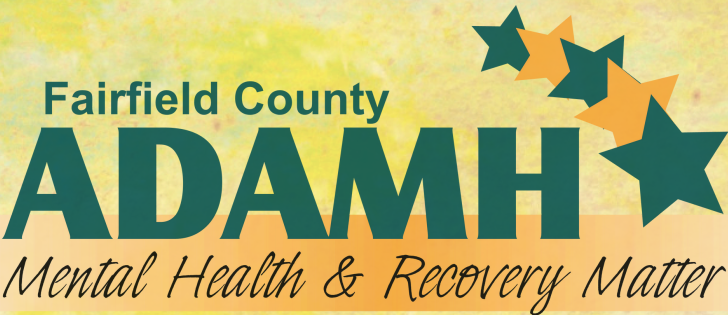

FY2024 was a busy year!!! Work on STARLight accelerated as we pushed to the finish line to open the crisis residential facility. Our second big project, Venture Place, was taking off with lots of energy spent on securing multiple funding sources for this important housing for the community. This theme of expanding and growing services and programs that our community has expressed a need for continued as a 15th Network of Care agency, Integrated Services for Behavioral Health was added. This addition increased the capacity for behavioral health services, including youth services.

The Board continued with an emphasis on workforce development and produced a series of videos to elevate and emphasize the benefits and positives of choosing to work in Fairfield County. The biggest event in FY24 for the ADAMH Board was the Annual Dinner - Growing a Healthier Community and Raising Hope. This was the first time we attempted a fundraising event, and it was a huge success! This event helped kick off the 2024 Levy Campaign. The agencies, board members and community rallied around us as we started this Levy campaign. The support we received was wonderful and affirmed the value our community places on mental wellness and health.
