A piece of property became available this winter which enabled the ADAMH Board to obtain sufficient land on which to build its <u>crisis stabilization/urgent substance use</u> <u>disorder center</u>. OhioMHAS suspended capital grants last year due to the pandemic but they became available once again this winter. The ADAMH Board is in the process of completing the necessary paperwork to receive funds to help with the cost of the center. Groundbreaking is targeted for this summer with building completion expected in 2022!

## **FUNDING UPDATES**

SFY 2022 (July 1, 2021 – June 30, 2022) Programs

This winter, the ADAMH Board approved mental health and substance use disorder prevention, crisis, treatment, and recovery supports funding for the upcoming year. The list of approved community-based prevention, crisis, treatment, and recovery support programs can be found by clicking here. School-based prevention funding totaling \$785,000 was designated on a per capita basis to each Fairfield County school district and the Education Service Center, A menu of evidenced-based programs offered by contract agencies and approved by Board staff was made available to the schools. The participation of each school district to choose the programming it believed best met its students' needs at this time is appreciated! The ADAMH Board, contract agencies, and schools will be completing the necessary contracts and memoranda of understanding to implement this programming in the 2021-2022 school year.

SFY 2022 purchased services and services on a go-forward basis are selected using a prioritization process. The Board laid the groundwork for this new prioritized-focused model at its November 2019 retreat with final details completed at its August 2020 retreat. The future prioritization process anticipates incorporating the systematic review of measurable outcomes initially established in fall 2021.

## State Opiate Response (SOR) Grant Funding Federal Fiscal Year 2021

The ADAMH Board in collaboration with contract agencies and community partners received over \$1 million in State Opiate Response (SOR) grant funding via the OhioMHAS for federal fiscal year 2021. 
