

JUST WHO IS THIS ADAM-H GUY?

When I started working with the Fairfield Alcohol, Drug Addiction and Mental Health Services Board this past March, a friend asked me who ADAM - H was - she thought the organization was a person! Of course I had to share the many facets of the ADAMH Board. Here's some good information for those of you who also thought, ADAMH was "some guy."

ADAMH stands for <u>A</u>lcohol, <u>D</u>rug <u>A</u>ddiction and <u>M</u>ental <u>H</u>ealth. The ADAMH Board is statutorily empowered to plan, develop, fund, administer and evaluate the local system of mental health and addiction services. Local Boards, governed by volunteer Board members appointed by the state and county commissioners do this work with a mix of federal, state and local funds. Ohio has 50 Alcohol, Drug Addiction and Mental Health Boards, covering all 88 counties. They provide community members with access to a defined continuum of care, inclusive of prevention, treatment and recovery supports in communities throughout the state.

ADAMH Boards are stewards of public, taxpayer funds dedicated to supporting community mental health and addiction services. Each local board has a fiduciary responsibility to ensure taxpayer funds are spent in an effective, efficient, transparent and quality manner to purchase services and supports needed by individuals in their community.

The Fairfield ADAMH Board consists of 14 volunteers who oversee the programs and projects in our county. This team hires the executive director who then hires a staff to carry out the board policies.

Marcy Fields serves as the Executive Director and works with her Board to manage a budget around \$9.3 million.
