





Student Demographics – Gender




Student Demographic – Ethnicity 10th and 12th grades combined








Trend: 30 Day Use Fairfield County Seniors




Binge Drinking

Of those who report drinking alcohol...



Attended Party Where Parents Allow Alcohol




Illegal Use of Rx Drugs - Lifetime # of times used - Seniors 2014




Used Rx 20 or more times






Prescription Drugs (Rx) and Heroin % of Seniors indicating very easy and somewhat easy access




Perception of Risk of Harm and Peer Disapproval Seniors 2014




Perception of Parental Disapproval Marijuana




Suicidal Thoughts Past Month




Suicide Attempts – Lifetime % Seniors 2014








Sexting and Gender




Have You Been Bullied or Teased?

Protective Factors

Clear Boundaries & Expectations

- Parents & Schools: set rules, enforce rules, punish for breaking rules (Always/Often)
 - In 2014, 84.1% of students reported that their parents set clear rules and 80.2% report that their parents enforce these rules. These figures illustrate a continued trend showing an increase in this protective factor since 2010.





Key Points: Marijuana

- The perception of risk and peer attitude toward marijuana is concerning.
- Marijuana is seen as a low risk substance
- Youth perceive it is riskier to drink alcohol and take prescription drugs than to smoke pot.
- Thirty day use of marijuana is higher than thirty day use of tobacco.

Key Points: Synthetics Education, Policy and Enforcement are key tools to reducing substance use

- Lifetime Use for all seniors dropped from 11.4% in 2012 to 6.1 % in 2014
- 30 Day Use for all seniors dropped from 1.4% in 2012 to .1 in 2014.
- Ease of Access dropped from
 - 29.4% in 2012 to 22.1% in 2014. (Seniors)
 - 30.9% in 2012 to 19.9% in 2014 (Sophomores)

^{*}Need for continued focus: Age of onset is younger for both seniors and sophomores. Education efforts targeting younger children recommended.

Key Points: Parents and Adults...keep talking!!

- Ask open-ended questions and then listen. Resist the temptation to dominate the conversation.
- Be a Good Role Model for Teens
- Promote Positive Behavior
- Be Honest with the Teen
- Monitor Your Child

Top 10 Reasons Prevention Matters

Clare Jones, director of prevention services at Helping Services, developed this great Top 10 list. It was published originally in <u>Prevention</u>, <u>Summer 2011 edition</u>.

- 10. Because it's cheaper to prevent problems than to fix them. It is estimated that the cost to the nation for substance abuse is more than \$500 billion dollars per year. For every \$1 invested in prevention we can save up to \$36. That is a lot of taxpayer money!
- 9. Sure, we've all heard "drink responsibly," but what does that mean? We need to have community conversations about what "low risk" drinking is, how we feel about drinking as a community, and how we model healthy behaviors for our kids.
- 8. Kids who use alcohol before the age of 15 are significantly more likely to have lifelong problems with alcohol. How will that affect their lives when they are trying to balance school, a job, and a family down the line?

- 7. We know that the teenage brain is not completely developed until one's mid-twenties. Adding substances to that still-developing brain affects health, school performance, and makes youth more likely to engage in a whole range of other risky behaviors. Being a teenager is challenging enough as it is. Why make it harder?
- 6. It is not as easy as "Just Say No." All kids need to hear that it is unhealthy and unacceptable for anyone under the age of 21 to drink or use other drugs. Let's teach them how to say no, how to make good choices, and how to deal with stress in healthy ways.
- **5. It is not just about having a designated driver.** Did you know that alcohol is involved in 50% of sexual assaults?

- 4. Because drinking too much significantly increases your chances
 of being injured or even killed. Think fatal car crashes, falls,
 drowning, and burns.
- 3. Because parents need to hear the message that they are the number one reason most teenagers choose not to use alcohol or other drugs. Your children might be telling you that you're lame, but we know they are listening. Kids who don't have parents who make clear rules about alcohol, tobacco, marijuana or other drugs are three times more likely to use them. Talking over family dinners is a great way to start the conversation about your rules and consequences!
- 2. It can be as simple as matching kids with a mentor who will take them fishing or out to get an ice cream cone. Believe it! The research tells us it's true: mentoring can prevent drug use. Kids who are connected with caring adults are less likely to use substances and more likely to do better in school and in life. Who do the youth in your life trust and feel connected to?

And the No. 1 reason that prevention is important is...

 1. Because you can connect almost every other social concern to substance abuse in some way: crime, poor health, poverty and abuse, to name a few. If we can make an impact on local substance abuse: smoking (tobacco and/or marijuana), underage drinking, binge drinking and other drug use, we can take a big step toward creating a healthier community and healthier lives for those living in Fairfield County.
